Hence Applications are invited for admission to Class –III, IV and V for the session 2021-22. In view of the pandemic situation caused by COVID-19 and in order to avoid large gathering of applicants or parents , the following arrangement has been made :

1.A Helpdesk with mobile numbers has been created to attend to the queries of parents / guardians related to admission. (Copy enclosed). Guidance will be given telephonically as far as possible, but in case of unavoidable circumstances, the applicants may be allowed to visit the Vidyalaya on a given date and time to resolve the issue. However all the directions of MHA/ State government / Local authorities and social distancing norms to contain the spread of Corona virus are to be followed scrupulously by visitors if any.

Desirous Parents are required to download the form and apply ONLINE i.e. the parents have to send the scanned copies of the filled-in Application Form along with all relevant enclosures within the scheduled date to the dedicated e-mail ID of school for admission: <u>kvsambalpur2admission@gmail.com</u>

  - 1. Certificate of proof of age in the form of a birth certificate (issued by the authority competent to register births ).

- 2. Bonafide Certificate from the Previous school
- 3. Proof of Residence.
- 4. A certificate that the child belongs to the Scheduled Caste/Scheduled Tribe/EWS/OBC (Non-Creamy Layer)/BPL/Differently abled, wherever applicable, issued by the competent authority. (If the child is not having the caste certificate in his/her name, then the certificate in the name of the parent will be considered. However they will be required to submit the caste certificate in the name of the child within three months of the child's admission.) OBC (Non-Creamy Layer) certificate should have been issued within the last three years i.e. on or after 01.04.2018
- 5. A service certificate as well as the certificate of number of transfers during the preceding 7 years duly signed and stamped by the head of office
- 6. A certificate of retirement for uniformed Defence employees.
- 7. For grandchildren of KVS employees a proof of relationship would be required.

4. The Application forms so received will be processed by the Vidyalaya as per KVS Admission guidelines 2021-22 and the Provisional selected list of candidates will be uploaded on the school's website as per the Admission schedule.

- Admission test shall not be conducted for admission to Class III, IV and V and the admission will be granted based on Priority Category system (I to V). If applications are more than the number of seats, lottery system will be followed in each category.
- The admission schedule for Class –III,IV and V will be as follows:

1	Registration	08/04/2021 (Thursday) to 15/04/2021 (Thursday)
2	Declaration of list	19/04/2021 at 4:00 PM (Monday)
3	Admission	20/04/2021 (Tuesday) to 27/04/2021 (Tuesday)

- The MINIMUM AGE as ON 31st MARCH 2021 should be 7 years and MAXIMUM AGE as ON 31st MARCH 2021 should be 9 years for Class-III.
- The MINIMUM AGE as ON 31st MARCH 2021 should be 8 years and MAXIMUM AGE as ON 31st MARCH 2021 should be 10 years for Class-IV.
- The MINIMUM AGE as ON 31st MARCH 2021 should be 9 years and MAXIMUM AGE as ON 31st MARCH 2021 should be 11 years for Class-V.

5. Documents as required at the time of admission will be produced by the parents on the given date and time in a dedicated box to be kept in the Admission dept.
