

DOCUMENTS REQUIRED:

PHOTO COPIES of the following DOCUMENTS need to be submitted along with the filled-in Application Form:

- 1. Certificate of proof of age in the form of a birth certificate (issued by the authority competent to register births).
- 2. Bona fide Certificate from the school in which the child is currently studying
- 3. Proof of Residence.
- 4. A certificate that the child belongs to the Scheduled Caste/Scheduled Tribe/EWS/OBC (Non-Creamy Layer)/BPL/Differently abled, wherever applicable, issued by the competent authority. (If the child is not having the caste certificate in his/her name, then the certificate in the name of the parent will be considered. However they will be required to submit the caste certificate in the name of the child within three months of the child's admission.) OBC (Non-Creamy Layer) certificate should have been issued within the last three years i.e. on or after 01.04.2019
- 5. A service certificate, a certificate from the Employer in the prescribed format, the certificate of number of transfers during the preceding 7 years duly signed and stamped by the head of office and Payslip . (in case of government servants only)
- 6. A certificate of retirement for uniformed Defence employees.
 - 7. For grandchildren of KVS employees a proof of relationship would be required.

III. The Application forms so received will be processed by the Vidyalaya as per KVS Admission guidelines 2022-23 and the Provisional selected list of candidates will be uploaded on the school's website as per the Admission schedule.

- Admission test shall not be conducted for admission to Class VI and the admission will be granted based on Priority Category system (I to V). If applications are more than the number of seats, lottery system will be followed in each category.
- The MINIMUM AGE as ON 31st MARCH 2022 should be 10 years and MAXIMUM AGE as ON 31st MARCH 2022 should be 12 years for admission to Class-VI.
